Roos Parish Council

Councillor G.E.Winter chaired the meeting of 14th December. Also present were Councillors Bowden, Cheeseman, Cook, Grant, Helliwell, and Priest. County Councillor R.S.Croft was in attendance. Councillors Clark and Quarmby sent apologies for absence.

THE MINUTES

The November Minutes were approved.

Irees. Mr Hemingway, the Borough Council's Tree Officer, had met the Parish Council and given advice about Tree Preservation Orders and other matters. There seemed no urgent need for local preservation orders, though there need might arise if new land was sought for development. Mr Hemingway was reminded of concern about trees removed near The Chestnuts, He stressed that, when the site was developed, the boundary hedge would have to be reinstated and an approved landscaping scheme would be required.

National Tree Week. It was reported that young trees for planting elsewhere in the village had already been delivered to the Parish Clerk.

<u>Main Street and other Roads</u>. Complaints at the last meeting about dangerous potholes were drawn to the attention of County Councillor Croft, who undertook to press the need for urgent action.

The Village Green. There had been no reply yet to the request for a meeting with representatives of the County Council Highways Department.

CORRESPONDENCE

<u>Electoral Register</u>, A draft copy of the new register had been received.

Community Council of Humberside. An invitation had been received to a meeting about voluntary groups and a possible Resource Centre in Withernsea.

Senior Citizens' Variety Shows, Details were noted, "What's On in Humberside". Local groups were urged to submit items for inclusion in the next printed Calendar, It was suggested that the Playing Field's

Fun Day might be included; details to be confirmed. "The Times" / R.I.B.A. Award Scheme. Awards were available for community building projects (including landscaping). Closing date: 12th February.

Holderness Design Award. The eligibility of the old school adaptation had been confirmed and the Clerk was to have an entry form sent to Mr Crook.

PLANNING

<u>Dent's Garth.</u> Some residents at Dent's Garth were concerned that — without planning consent — the Keyingham Construction Company had not only extended their existing premises but had erected a wooden office on the eastern side of the road on land belonging to the church, Mrs B. Quinn had written about the matter, enclosing copies of letters sent to the Planning Department of the Borough Council,

The Chairman said that he had attended a site meeting with the Borough's officers and representatives of both Keyingham Construction and of the Church (the Rector and Er John Kirkwood).

Councillors noted the anxiety of the residents concerned but felt that action could be taken only after Keyingham Construction had submitted a formal planning application to regularise their position. The public could then exercise their right to register objections and the Parish Council could reach a considered decision.

Hilston Road. Mr M.Hunt, of Eastfield Farm, Halsham, had applied for permission to build four houses on the eastern side of Hilston Road (0.S. Field 143). The Parish Council did not support the application; it was contrary to the Village Plan, which had identified other areas - within defined "village limits" - appropriate for residential development.

The Black Horse. The Parish Council supported an application by Messrs Joshua Tetley, Leeds, to erect an illuminated sign showing their huntsman motif on the west wall overlooking the car park.

Holderness Cottages, Owstwick, The Council supported an application by Mr T.Billany for a kitchen extension and septic tank.

Applications now decided by the Borough Council ; Approved.

Bungalow and single garage at 9 Chestnut Garth. Revised plan and temporary site for caravan, Hilston Road - 0.S. Field 47.

Refused

Application by Yorkshire Water Authority to replace the pumping station at North End by a pre-cast concrete structure.

PARISH RATE 1988 - 9

The product of a 1p rate had been £824 in 1986-7 and would probably be £819 in 1987-8. The balance held for the Parish at Skirlaugh was estimated at £56. The Treasurer reported that there was £544.48 in the bank. In the light of these figures, the Parish Council agreed to ask for £650 for the year 1988-9 on the assumption that this amount would need no more than a 1p rate.

ACCOUNTS

The Treasurer had no transactions to report, Councillor Helliwell referred to the Council's offer of £12,00 to support "The Rooster" before the donation scheme was fully under way. The grant would be welcome to meet costs of the December issue, Payment of the £12,00 was approved, Subsequent costs would be met by donations from residents.

ANY OTHER BUSINESS

Councillor Helliwell referred to "Humbrella", the two-monthly newsletter produced by the Community Council of Humberside. He quoted useful items from the current issue and urged councillors to obtain their own copies. Alternatively, the Parish Council could pay a corporate subscription (& £2.00 per annum). The Clerk said that he was already a private subscriber. There was no agreement to take out a Council subscription.

PUBLIC SESSION

<u>Oove Lane Development</u>. Mr John Waldron referred to the application for residential development on land south of Dove Lane. This application had already been decided by the Borough Council. Their decision had been reported both in the press and in the official Minutes available in public libraries. It was a significant decision, one that the Parish Council should have discussed, even though it had not yet been officially notified from Skirlaugh.

The Village Plan. Councillor Helliwell had himself heard disquieting accounts of the discussion preceding the Borough Council's decision. It had been suggested that the Roos Village Plan used by the Parish Council was only a draft version and that a final version existed that was in significant ways different. He asked if this was the case. He said that the Borough Council should be asked for clarification. Because the Parish Council meeting was officially over, it was ruled that an enquiry to the Borough Council could not be approved.

(In answer to a telephone query from "The Rooster", Mr Colin Hogg, of the Borough's Development Department, confirmed that a "final" version of the Roos Village Plan does exist. Of the areas suitable for residential development, low-density housing is still recommended for Site C - south of Dove Lane - but the suggested limit of six new dwellings there

has gone, Mr Hogg also said that on 9th December a planning application was received from the Keyingham Construction Company for "retention" of the extensions at Dent's Garth, A copy of the application is now held by the Parish Clerk and the matter will be discussed at the next Parish Council meeting.)

G. W. Wilbraham: A History of Roos : 2

(This item is a selective built in the main centres abridgement of the next part and the Canons went out on of the "History",)

A 9th century Anglo-Saxon bronze pendant was found in a local gravel pit before the 1914 War. It was given to Hull Museum by Miss Dickinson and was transferred from the Mortiner Museus the to Transport Museum in High Street, The pendant, 1%" long. is in good condition except for two small holes pierced through it. The back is perfectly plain but on the front is a Maltese Cross formed by four triangles of Anglo-Saxon interlacing. The entire edge of the pendant and of the cross itself is decorated with a line of small punctures: and in the centre is a large puncture surrounded by a number of smaller ones.

The Saxons generally preferred peace to fighting and over the life centuries improved. Government was fair and to some extent democratic. The country was divided into settlements with agreed boundaries, many of which have not changed since.

The country was Christian before the Saxons came and gradually the Saxons were converted, Churches were built the faithful were ministered to by monks. There was no monastery in Holderness but there was one just over the River Hull at Watton. Later Collegiate Churches were

missionary tours. Then the parochial system developed and each parish or manor had its own parson. In fact, the lord of the manor was required by law to build a church in his manor. That is why later - in the Domesday Book - Roos is recorded as having a church and a priest.

The lot of the Saxon peasant in some ways does not suffer in comparison with that of the Roos villager today, Of course, he was without many modern amenities but he did not know of them or wiss them. He had no anxiety about employment as he the lord's worked on demesne, For that, he had a small plot for himself and rights on the commons, His house let in water, but it let in air - and it was his

In winter he doubtless ate too much salt meat, which made him ill: but in summer he had wholesome food, He ate what he produced because he could not sell it to buy tinned meat and preserved milk in its place. He never sat up late because there was no light to sit up by. He had a garden for himself and his family. In the main he did as he liked - and seldom washed!
