#### Roos Parish Council

The meeting of 9th May was preceded by the A.G.M. All councillors were present, with Councillor G.E.Winter in the chair.

#### Annual General Meeting

The Minutes of the 1987 A.G.M. were approved.

#### Elections

Chairman: Councillor G.E.Winter, <u>Vice-Chairman</u>: Councillor J.D.Quarmby, <u>Treasurer</u>: Councillor M.Cheeseman, Representation on other bodies:

Councillor Grant reported that balances for the two charities were ; Snaith, £189.16; Roos, £25.13. He said that the Rector was ex-officio Chairman of both charities and thought that balances should be allowed to build up, although the Snaith Charity - restricted to residents of Tunstall - could be drawn on to meet a case of urgent need.

#### Treasurer's Report

At the end of March there had been a balance of £673,09, Subsequent payments had reduced this by about £180. The Parish Council's 1988-9 rate income would be received in June, Reimbursement of the cost of one of the seats paid for by the Council had been received from the Roos Young Farmers' Club.

#### May Meeting

#### Minutes

The Minutes of the April meeting were approved, Under "Matters Arising" the following items were discussed,

<u>Grass Verges</u>. The Chairman referred to the verge opposite the Roos Arms. There had been further damage - by a vehicle <u>other than</u> a brewery lorry, Councillor Helliwell reported that the landlord of the Roos Arms had been irritated by the implication that only

brewery lorries were responsible; other large delivery vehicles used the pub entry to turn round. The Chairman referred to the meeting with Mr Holden of the Highways Department, who had said that running on to a grass verge was unfortunately not illegal. It was agreed that the Clerk should write thanking Mr Holden for a helpful meeting but urging the need, when the main road was improved, to install kerbs to discourage further damage to verges. A copy of the letter was to be sent to County Councillor Croft.

<u>Dove Lane</u>. Councillors were surprised that, according to the Highways Department, Dove Lane was regarded as an unclassified road rather than a footpath, It was agreed that the Clerk should query this designation.

Litter Bins. Councillor Bowden reported that refuse collectors preferred to handle bins with lids and metal liners. Such bins (including liners) would cost £54 each, though they might be cheaper if ordered through the County Council. Presumably fixing them to telephone and electricity poles would be permitted. It was agreed to order one bin as a trial and possible more later in the light of experience.

#### Correspondence

Path from Dent's Garth, The Rector had replied to the Clerk's letter, He said that the path from Dent's Garth to the churchyard gate did not belong to the church and he was mystified why he should have been asked to write to express the Parish Council's appreciation to Mr Robinson for clearing it - though he was willing to do so. Councillor Quarmby asked whether, if the land did not belong to the church, it was public land. If so, the Parish Council had a duty to enquire about it and possibly acquire it on behalf of the village, It was noted that the York Diocese had disclaimed responsibility for the path past the actual dwellings at Dent's Garth. It was agreed that the Clerk should write to the Land Registry to establish ownership of the land from the start of Dent's Garth southwards towards the church,

Annual Audit of Parish Council Accounts : 20th June.

Scrap Cars at North End, An officer of the Development Department had visited the site, The garage owner was to apply for planning consent to

operate an official scrapyard. The application would be referred to the Parish Council in due course.

Village Ventures 1988. Literature advertising this competition, run every two years, had been received from the Community Council of Humberside. Councillor Helliwell said that in 1986 the Roos Village Appraisal had won a small but welcome award and local ... groups should be encouraged to enter. Details were passed on for consideration by the Institute Committee and the Playing Field Committee.

#### Planning

Borough Council consent was notified for ; <u>Cross Roads Cottage</u> ; two-storey extension, <u>North End Cottage</u> ; pitched roof for flat roof, <u>56 Pilmar Lane</u> ; only one of two trees to be moved,

#### Accounts

Payment was approved of the Clerk's salary and expenses (total £133,40) and the annual subscription to the Association of Parish and Town Councils.

#### Outstanding Items

<u>The Village Green</u>. It was agreed that landscaping would be costly and that, to assess local opinion, the subject should be on the Agenda of the next Parish Meeting.

<u>Best-Kept Village</u>. Slips inviting views on entering the competition had been circulated in "The Rooster" in August 1987. Few had been returned. It was agreed that this was another item for the Parish Meeting.

Motor Cycles, The Chairman said that nuisance from motor cyclists was a police matter. The Parish Council were powerless.

The School Clock. Councillor Helliwell was pleased that the clock had been so effectively installed in the Institute but pointed out that the Parish Council's last decision about the clock had envisaged a legal document setting out the village's title to it. Since the clock was now housed in a public building, the Council should formally approve its installation and express satisfaction that elected committees of the Institute, now and in the future, were appropriate custodians. Councillor Quarmby suggested that a plaque should be provided by the Parish Council; it should explain how and when the clock was first provided by public subscription and record appreciation of the work done in rehousing it. Members warmly approved the proposal.

#### Any Other Business

"Taking the Chair". Councillor Helliwell referred to a seminar on chairmanship at Patrington Village Hallon 7th July, organised by the Community Council. Anyone interested was welcome, not just existing chairmen — and not just parish councillors. Booking was necessary (0430 430904) at least ten days in advance and there would be a charge of £1.00. Thanks to the Clerk, Councillor Quarmby was warmly

supported in expressing appreciation of Mr Cyril Woodhouse's conscientious service as Parish Clerk during the past year.

Annual Parish Meeting. It was agreed that the agenda and date (late June or July) would be decided at the next meeting

#### Dent's Garth

Mr Ken Lawson has written to correct an error in the article about Dent's Garth in the April newsletter. It had been assumed that the cottages at Dent's Garth passed to Colonel Reckitt from the Dickinsons. In fact the cottages were never owned by Colonel Reckitt.

Documents in Mr Lawson's possession show that the cottages passed in 1892 from the heirs of Rev. Charles Hotham to the Dickinsons and the then tenants (i.e. Mr Lawson and Mr A.Robinson) were able to buy them in 1950.

As to the path past the Dent's Garth cottages towards the church, the deeds of the cottages show the path running outside their boundary line, suggesting — in view of the "Sunday school" building that formerly stood nearby — that the path belongs to the church.

Yet the Rector has said that the church does not own this land - i.e. the land on which the track runs southwards as far as the church gate. He has not yet disclaimed the land on which Keyingham Construction have put up their portacabin and made a car park.

#### Church Accounts

The accounts of All Saints', Roos, for 1987-8 have been posted in the church porch. As the Rector said in the February issue of the Deanery Magazine (reported in the March newsletter), a substantial sum (£11,000) was transferred to an Endowment Fund in 1987 and is apparently earning good interest. Details of income and expenditure are given, including the cost, in 1986 and 1987, of restoring the churchyard wall - a total of over £1800.
