### Roos Parish Council

The meeting on 13th February was attended by : Cllrs Michael Cheeseman, Ken Cook, Alec Dodson, Kenneth Grant, Leslie Helliwell, Barbara Kirk, and David Winter (Chair). East Riding Cllr Richard Stead was also present.

Apologies for absence : Cllrs David Craggs and Jane Smales.

#### Declarations of members` interests

No changes were notified.

#### Minutes

The Minutes of the January meeting were approved.

#### Correspondence

##### Mr McWatt : Wind turbines

Mr John McWatt, Chair of Rimswell Parish Council, urged local parish councils to collaborate in opposing onshore turbine planning applications. Cllr Winter said that Mr McWatt would speak in the public session later.

##### ERYC : Landscape Character Assessment

The assessment has identified 80 distinct areas throughout the whole East Riding. Each is assessed in terms of quality, value, sensitivity and capacity for development. The assessment will influence planning decisions. Copies cost £55.00 + p & p or the document may be viewed on :

##### ERYC : Sustainability Matrix

A copy of the matrix had been sent. It tabulates for each parish in the East Riding its scores on various criteria to assess its overall capacity for growth.

Meetings are to be held for parish council representatives to discuss the implications of the matrix for their own area. One meeting will be in Withernsea on 23rd February. Cllr Kirk said that she would like to attend. It was agreed that Mr Willis Ainley, Chair of the Parish Plan Committee, should also be invited to attend as a parish representative.

##### ERYC : Aldbrough Road

A temporary (18-month) 40 mph speed restriction was to be set to allow construction of the staggered junction.

Access would remain open. Cllr Helliwell noted that it was intended eventually to make the restriction permanent.

##### ERYC : Local arts events

A poster has already been displayed publicising the events, including "The Good Old Days" at the Northfield, 2.00 pm on 17th March. (Tickets @ £4.00 from the Withernsea Customer Service Centre.)

##### Strategic Health Trust consultation

Two public meetings have already been held about proposed changes. The Trust invited members to comment on the proposals.

##### RES : Proposed wind farm at Sunderland Farm, Roos

In preparation for a public consultation, Renewable Energy Systems sought comments on the "visual representations" they should provide, including viewpoints from which photomontages should be constructed.

##### ERYC : Register of Electors

Six changes were notified.

##### ERYC : Community Cohesion

A trainee researcher wanted advice on the ways in which the community welcomes newcomers :

How do we know when new people move in? What do we do then? Would the parish like ERYC to supply a welcome pack with details of our parish? Could ERYC help in other ways?

A short questionnaire was answered during the meeting.

Cllr Helliwell said that the Parish Plan recommended a welcome pack for newcomers. It would be better produced locally rather than be a small part of an ERYC document. No member disagreed.

##### ERYC : Information on planning applications

ERYC planned to pass information to parish councillors on the its website and via e-mail.

A questionnaire asked about the Parish Council`s ability to access such information.

In order to supply the details the Parish Clerk updated her note of members` individual e-mail addresses.

##### East Hull Park & Ride

Although the scheme at Queen Elizabeth Dock was intended as a temporary means of reducing Hull

traffic while North Bridge was being refurbished, its popularity has led to its being extended. It will be subject to regular review.

#### **ERYC : Chairman`s Awards**

Judging will take place in February and the winners will be announced at a ceremony in May. (The Parish Council nominated Mr & Mrs Walter Holbrook and Mrs Ann Coupe.)

#### **ERYC : Parish Council liaison meetings**

A summary was received of issues discussed at the councillors` meetings in Goole, Bridlington and Beverley. It included discussion of the Sustainability Matrix referred to in a previous item. A covering letter referred again to the meeting in Withernsea on 23rd February.

#### **Roos School : Not a source of litter**

Mrs Farey, Headteacher, responded to the letter requesting help in reducing litter. She said that litter did not come from the school, which had its own bins. Litter left by youths after hours was put into the school`s bins. The school had projects to improve its own environment and Mrs Farey was keen to collaborate in any Parish Council initiatives to improve the environment in general.

#### **ERYC : Streetscene**

Officers would carry out a preliminary inspection of the streets in August. The full "Streetscene" walk to identify desirable improvements would take place on 11th September.

#### **ERYC & Hull City Council : Target 45**

The two councils are collaborating on a draft joint strategy for sustainable waste management called "Target 45+". For details see :

A hard copy is available on request.

The strategy is based on consultants` recommendations for dealing with municipal waste. The scenario envisages a high recycling rate of 45% (hence Target 45) and the generation of energy from the residual waste.

Erection of conservatory. Approved.

South of the Old Rectory, Roos (Mr & Mrs T.Stone)

New vehicular access to paddock for agricultural use. Resubmission. Approved.

22 Pilmar Lane, Roos (Mr C.Kettley)

Single-storey extension. Approved. Condition : the garage to be used for the dwelling, not for commercial purposes.

#### **New application**

58 Pilmar Lane, Roos (Mr & Mrs P.Moate)

Full planning consent sought for a single-storey extension. Members recommended approval.

### **Accounts**

Members approved payment of an account tabled by Cllr Winter, Treasurer :

### **Draft Parish Plan**

Some councillors had been able to attend a special presentation about the draft in the Memorial Institute. All had been supplied with a copy. The draft was approved as a Parish Council document.

(It will now be submitted with supporting data to the Community Council in Leeds. This should result in release of the remaining grant to meet future costs, mainly the printing bill.)

### **Any other business**

#### **Aldbrough crossroads**

Cllr Dodson noted that some preparatory work for the new junction was already under way. He assumed that phone lines under the verges were being moved.

Members knew that the work was once to have been completed by December 2005. Cllr Stead said that there had been delay because of tight funding. It was agreed to seek a current estimate of the likely date of completion.

### **PUBLIC SESSION**

#### **Parish Plan Committee**

Mr Willis Ainley, Committee Chairman, commented on points raised in the meeting.

Landscape Assessment Report. The Report included two chapters relevant to Roos Parish.

Roads and footpaths : meetings with Highways officers

The officers had been shown photographs of roads and footpaths under mud and water. They regularly inspected the roads but would come again when the weather was especially wet. They admitted that Hodgson Lane needed complete regrading but the work could not currently be afforded, though an additional footpath might be possible. The footpath on Rectory Road might be improvable by changing the level of the gullies.

The officers had been urged to include the whole parish, not just Roos village, during the Streetscene operation in August and September.

Welcome pack for newcomers. A pack for Roos parish would be better than an East Riding pack.

Litter and dog fouling. Offenders could be penalised under existing legislation. The problem was apprehension and enforcement.

A Tunstall resident said that the Parish Plan had not dealt with the issue of mud on the Tunstall roads. Mrs Cherie Blenkin said that there was a need to protect wetland sites.

Cllr Dodson complimented the Committee on the Parish Plan. It was very thorough and well organised and must have occupied a vast amount of their time.

#### **Wind Turbines**

A separate report is given below.

#### **Hedges and Dog fouling**

Mrs Ann Coupe said that the hedges on the track to the

playing field needed cutting back and asked who was responsible. The Chairman, on behalf of the Playing Field Committee, said that they were.

Mrs Coupe also complained that, though dogs were forbidden, owners were exercising their animals on the playing field and the track to it. (See her Children's Playground item below.)

## **Wind turbines**

#### **Mr John McWatt**

When E.ON UK first introduced the Tedder Hill project to local councils Mr McWatt had offered to act as contact person for E.ON.

He had asked to speak at the present meeting because, along with other Rimswell residents, he wanted to urge the importance of collaboration between parishes to oppose wind turbines in our area..

He gathered that in order to build the wind farm the parts and materials would have to be transported via Withernsea to Rimswell and then over a new road to be made across a 100-year-old meadow.

In a letter Chantal Thomas had claimed that 86% of those attending E.ON's consultation in Roos had been in favour of the project. Mr McWatt said that the photomontages had been unhelpful : better viewpoints should have been used. Chantal replied that the viewpoints had been chosen by the East Riding, though this was disputed.

Mr McWatt said that there would be a sub-station the size of a double garage, though its siting was not yet known. Too much information was still not available. Further, the opinion survey carried out in Roos was now invalid since the issue was now not 3 turbines but 14 since RES had a project for 11 at Sunderland Farm.

Mr McWatt wanted joint action to oppose wind turbines and a public meeting to mount it. He intended to write to all relevant parish councils to solicit support.

#### **Other contributions**

**Cllr Mrs Barbara Kirk.** Mrs Kirk read extracts from a letter from RES to residents in Pinfold Lane – and presumably to others who might deem themselves affected by the Sunderland Farm project. There was an invitation to the exhibition in Roos on 22nd February and an offer of a personal visit by the writer. The letter described the reputation of RES in producing green electricity and outlined the community benefits to local residents, including, "perhaps cheaper electricity to local householders..."

**Mr David Kirk.** Mr Kirk said that the Parish Plan showed that residents valued the openness and peace of the countryside which would be spoilt by turbines, power lines and sub-stations. Parishes must take joint action.

**Mrs Cherie Blenkin.** Mrs Blenkin said that access for RES to Sunderland Farm would be by a track near the drain south of the church. There could be an effect on drainage and Roos Bog, an SSSI (site of special scientific interest).

**Mr Mike Blanchard.** Mr Blanchard said that SHOWT

still existed (South Holderness Opposes Wind Turbines). A joint SHOWT committee should be set up for Rimswell, Roos and other parishes. He proposed a public meeting after the RES presentation. It should be held in Roos on Saturday 25th February. The proposal was well supported.

**Mr Richard Priest.** Mrs Kirk read a letter from Mr Priest, who lives part of the way to Sunderland Farm. He asked who would stand to gain financially from wind turbines there. He was concerned about their effect on horses kept by his family. Unspoilt views over open countryside would be ruined by such huge turbines.

## Anglican : Roos United Benefice

### From Rev Gordon Smethurst, Roos Rectory

Yes – Roos Church is a "Gem of Holderness". This has been confirmed by diocesan and national architects, seeing it as a building of great merit, thoroughly deserving its Grade 1 listing.

They recommend a list of essential works : to the tower, the north aisle, the nave roof, the north clerestory, the north chancel gutter, the drain-aways and the north side margins.

The estimated cost is in the region of £120,000, a figure well below the means of the small congregation and perhaps even of the village.

However, the architects` recommendations may well find favour with a number of trusts that may assist with major awards. PPC member Tim Newton is enthusiastically and confidently presenting the project to such trusts.

# The Rooster

## Financial Statement : 1st January to 31st December 2005

### Circulation

"The Rooster" is supplied to 522 addresses, including some outside the parish. It is funded almost entirely by voluntary donations from its readers.

### Income

Income depends on donations, not advertising. Nevertheless, although local groups are offered free publicity for their coming events, businesses and individuals who advertise their services are charged a small fee.

In 2005 187 households (35.8%) donated £920, an average of £4.91 per household.

Paid business advertisements contributed £90.

### Expenditure

(See the table alongside)

#### Printing

Printing is done in Hull by David Scotney and the charges are very reasonable. Printing costs just over four fifths of the total. The bill varies from month to month depending on the number of pages in a particular issue. Pages including photographs usually cost a pound or two more to set up.

#### Fuel

The cost of driving to the printer and taking batches of newsletters to the volunteer deliverers (an overall total of 42½ miles) has been claimed as expenses. In 2005, because of variations in petrol prices, the rate has veered between 12p and 14p a mile.

#### Phone calls

Phone calls are logged (though some are overlooked). Most are local calls, claimed at 5p a minute. Occasional national calls are timed and claimed conservatively.

#### Postage

Second-class postage is normally claimed, mainly for newsletters mailed to donors outside the delivery area.

#### Stationery

Stationery expenses include envelopes actually used and the purchase of staples from time to time.

Copying includes both photocopies and pages printed by computer as working drafts and as final copy for the printer. The rate claimed is 5p per A4 page (instead of claiming for printer cartridges as in some previous years.)

#### The bank account

The current account is held at Halifax plc. It has to be in my name since I am at present solely responsible – I am not (yet) a club or association!

As in previous years there is a healthy balance.

However the increase of £242.90 is misleading. Some 2006 donations had already been paid in December 2005 and the cheque for the November and December printing was not cleared until January 2006. Expenses for the second half of 2005 were not claimed until February 2005.

Reconciling bank statements with annual income and expenditure is beyond my limited accountancy expertise.
